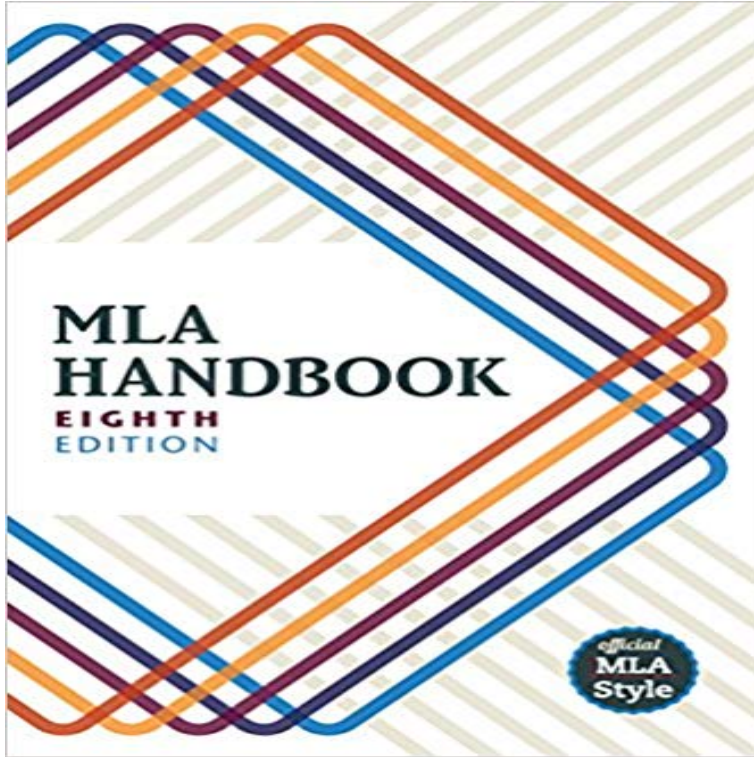


MLA Handbook
